The Macomb County Department of Roads (MCDR) will receive sealed bids for the following highway improvements until 11:00 a.m. EST, Thursday, August 1st, 2019, at the Macomb County Department of Roads, 117 S. Groesbeck Highway, Mount Clemens, Michigan 48043 at which time and place all bids will be publicly opened and read:

PROJECT DESCRIPTION:

WO No. 1735 (Ponchatrain Street): This project includes: crush and shape of existing roadway, existing drainage structure adjustments, 4" of HMA Paving and turf establishment in Harrison Township, Macomb County.

WO No. 1755 (Sunrise Boulevard): This project includes: hand patching, 1.5" overlay, removal of existing 60" CMP culvert, installation of proposed 60" reinforced concrete pipe, and guardrail removal and installation in Chesterfield Township, Macomb County.

WO No. 1756 (Meadow Lane): This project includes: crush and shape of existing roadway, existing drainage structure adjustments, 4" of HMA Paving and turf establishment in Chesterfield Township, Macomb County.

WO No. 1760 (Brentwood Street; Fairlane Drive; Beuren): This project includes: pavement removal, sidewalk removal, sidewalk installation with ADA ramps, hand patching, HMA Wedge and 1.5" HMA overlay, removal of existing culvert, installation of proposed storm sewer, existing drainage structure adjustments, and turf establishment in Shelby Township, Macomb County.

WO No. 1783 (Generaux Street): This project includes: sidewalk removal, sidewalk installation with ADA ramps, crush and shape existing roadway, existing drainage structure adjustments, 4" HMA Paving and turf establishment in Harrison Township, Macomb County.

Specifications will be on file and will be available on or after Thursday, July 11th, 2019, at the Macomb County Department of Roads Administration Building, 117 S. Groesbeck Highway, Mount Clemens, Michigan. Specifications will be available electronically for no fee. **All downloadable files are password protected.** Prospective bidders must send an email to Melissa Hollebrands at mhollebrands@rcmcweb.org for an electronic version in Adobe Acrobat PDF format. Bidders, please provide your name and company name in your email. The bidder will then receive a reply with the proposal and/or plans passwords. It will be the bidder's responsibility to print out the proposal entirely and then submit it to the Macomb County Department of Roads by the date listed above. **No proposals will be accepted by email.** If a hard copy of the proposal is preferred, they can be released upon payment of a \$30.00 **NON-REFUNDABLE** (CHECK ONLY-no credit cards or cash accepted) fee. Prospective bidders must have current prequalification with the Michigan Department of Transportation in the proper classification and numerical rating required for the work to bid.

NOTE: BIDS WHICH DO NOT COMPLY WITH THE FOLLOWING PREQUALIFICATION REQUIREMENT MAY NOT BE READ AT THE DISCRETION OF THE MCDR:

1. The prequalification rating shall be on file at the Macomb County Department of Roads, or shall be attached to the bid. However, a letter from the Department of Transportation may be accepted if the letter discloses that the prequalification rating with the Department of Transportation is extended, is currently in effect, and has not lapsed.

2. A Contractor whose prequalification's have expired, and is unable to supply with the proposal a letter of extension from the Michigan Department of Transportation prequalification unit, as described in paragraph 1 above, shall certify in writing that their prequalification has been extended by the Michigan Department of Transportation until such time as their new rating can be issued. Certification means a written, notarized affidavit under oath, setting forth facts (dates, times, and individuals) which will serve to substantiate the contractor's claims of classification. If this certification does not accompany the bid, the MCDR in its discretion may elect not to read the bid.

NET CLASSIFICATION: 932 Cb sub Ea

A satisfactory Bid Bond, Certified or Cashier's Check, Bank Money Order, or Certificate of Deposit on an open, solvent bank in the amount of not less than 5% of the total bid and made payable to the Macomb Department of Roads shall be submitted with each bid.

The MCDR at its discretion reserves the right to reject any or all bids and to waive any irregularities in the bidding process and to make the award as may appear to be in the best interest of the County of Macomb.

No bid may be withdrawn after the scheduled closing time for receiving bids for at least 45 days. No proposal will be received unless made on blanks furnished by and delivered to the Macomb County Department of Roads on or before Thursday, August 1st, 2019, 11:00 a.m. EST.
